

AMENDED ARTICLES OF INCORPORATION
of the
UNIVERSITY OF THE PHILIPPINES ALUMNI ASSOCIATION, INC.

KNOW ALL MEN BY THESE PRESENTS:

The undersigned incorporators, all of legal age and a majority of whom are residents of the Philippines, have this day voluntarily agreed to form a non-stock corporation under the laws of the Philippines.

AND WE HEREBY CERTIFY:

FIRST. – That the name of said corporation shall be:

UNIVERSITY OF THE PHILIPPINES ALUMNI ASSOCIATION, INC.

SECOND. – That the purposes for which such corporation is incorporated are:

1. To assist the University of the Philippines continue its role as the leading center of learning and research in the Philippines. To serve as a meaningful medium thru which the alumni can collectively channel their resources and participate in the promotion of higher education in the country. To receive loans, gifts and deposits of money, to issue notes, to acquire, possess and hold titles to, real, personal and fixed estates, either in trust, or otherwise, by gift, bequest, devise or purchase.
2. Generally to do and perform those various acts and things which are necessary, proper and incidental to the purposes herein-above defined and those acts and things which are legally inherent in the powers of corporations organized under the laws of the Philippines.

THIRD. – That the principal office of the corporation is located in Metro Manila, Philippines.

FOURTH. – That the term for which said corporation is to exist is fifty (50) years from and after the date of the issuance of the certificate of incorporation.
